Move ups in obedience or rally will be accepted, but must be presented to the Show Secretary before the first class of that event.

TELEGRAPH, TELEPHONE, AND UNSIGNED ENTRIES CANNOT BE ACCEPTED. Entries not on official AKC entry forms and photocopies of entry forms without the agreement and rules on the reverse side of Official AKC entry forms are not acceptable.

**From South:** Take I-75 to exit 116 Bristol Rd (toward Bishop International Airport). Keep **left** at the fork, follow signs for Bristol Road W and merge onto W Bristol Rd. Go east .3 miles to Torrey Rd. Turn right near the Marathon station. Companion Dog Training Club is .2 miles on the left.
