ENTRIES WILL NOT BE ACCEPTED WITHOUT FEES. A SEPARATE ENTRY MUST BE MADE FOR EACH CLASS. PLEASE PRINT OR TYPE INFORMATION CLEARLY. Full Payment must accompany entries, partial payment will not be accepted.

ENTRIES CLOSE at the Herding Test/Trial Secretary's office, Wednesday, September 20, 2023 at 6:00 p.m., or when numerical limits are reached if prior to that date, after which time entries cannot be accepted, canceled, altered or substituted.

DRAWING for running order will be held at the Herding Test/Trial Secretary's office on Wednesday, September 20, 2023 at 7:30 PM.

ENTRY FORMS MUST BE SIGNED by the owner or the owner's duly authorized agent, otherwise entry cannot be accepted.

ERRORS ON ENTRY FORMS. Owners are responsible for errors in making out entry forms (whoever may make such errors) and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. Please type or print clearly and carefully the information on entry forms to eliminate errors.

DECLINATION OF ENTRIES: Shetland Sheepdog Club of Greater Detroit, Inc. (SSCGD) may decline any entries and may remove any dog on account of disease, viciousness, or other cause and no one shall have any claim against SSCGD or any official thereof.

ENTRY FEES SHALL NOT BE REFUNDED in the event a dog is absent, not allowed to compete in the entered class, disqualified, excused, by a Veterinarian or Judge, or barred from competition by action of Show Committee, or if because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the Test/Trial, no refund of entry fee will be made.

BITCHES IN SEASON will be permitted to run in **test classes** at the end of the class, bitches in season in **trial classes** will be run in catalog order.

ALL DOGS PRESENT MUST BE HELD ON LEASH or otherwise restricted except when in the exercise ring. Under no circumstances will dogs be allowed to disturb the resting stock or interfere outside the arena with another dog's performance in the arena. See Chapter 1, Section 20 of the AKC Herding Regulations.

EXPRESS ENTRIES – If you send your entries via any type of express mail you **MUST** waive recipient signature.

Test/Trial location will be available from 7:30 am to 6:00 pm or one hour after conclusion of Test/Trial. **No training or practicing in arenas from Fri, Oct 13 at 3pm until Sun, Oct 15, 2023 at 6pm**

Owners or their Agents are solely responsible for the presence of their dog(s) at the Test/Trial arena. Judges are not required to wait for dogs.

Exhibitors are expected to maintain the premises in a clean, tidy condition and to pick up after their dogs.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

NOTE: Primitive RV or Camping (No Hook Ups) is available this year, and no generators are to be run during show hours. Contact Cheryl Smith at clsdvmbwt@aol.com to place a reservation. Places are limited.

Stock replacement value: Cattle Market Value; Sheep \$150 per head, and ducks \$50 per set even if only one duck.

Refunds/Alternates

If you pull your entry (ies) prior to closing your check will be either returned or a full refund made.

If your dog is pulled after entries close and an alternate fills your place, a full refund will be made.

If your dog is pulled after entries close without an alternate taking your place, no refund will be made. In the event of a spouse, sibling, parent or entered dog's passing, a board decision will be made.

If you are an alternate and pull prior to closing your check will be returned.

If you are an alternate and do not have an opportunity to run, you will receive a full refund.

If you are an alternate, have the opportunity to run and are not present to run your dog, no refund will be made.
